

JAT EDUCATION SOCIETY (REGD.), ROHTAK

ORDER

Whereas, the Hon'ble High Court of Punjab and Haryana vide its order dated 04.08.2015 in CWP No. 14627 of 2015 titled as Surender Singh V/S State of Haryana and others, has directed the Administrator, Jat Education Society, (Regd.), Rohtak (herein after called as JES) to hold the elections within a period of four months from the date of its order. The undersigned was appointed as an Administrator by the State Government vide order No JES Rohtak/628-30 dated 16.7.2015.

That the Governing Body of Jat Education Society, (Regd.), Rohtak vide resolution No.6 dated 28.6.2013 has adopted geographical basis for the constitution of electoral collegiums and the said amended bye-laws of the society have got duly approved by the District Registrar of Societies, Rohtak as per the Haryana Registration & Regulation of Societies Act, 2012 on 27.6.2014. In this regard, a clarification was further sought from the District Registrar of Societies, Rohtak vide letter no-106/jes dated 18/09/2015 whether the collegiums for the purpose of election as directed by the Hon'ble High Court of Punjab and Haryana will be constituted on the basis of geographical basis as per the approved/amended bye-laws of the Society or not.

District Registrar of Societies, Rohtak vide letter no. DIC/F&S/Roh/2231 dated Rohtak, the 21-09-2015 clarified that:-

"The collegiums may be framed on the basis of Geographical basis i.e. as per the approved bye-laws of the Society. "


Keeping in view the above facts, the undersigned formed the 105 collegiums on the basis of geographical basis.

The Election to 105 collegiums of Jat Education Society will be held on 10.3.2016. The election schedule is as under:-

Therefore, by virtue of powers conferred upon me, I, Dusmanta Kumar Behera, IAS, Administrator, Jat Education Society (Regd.), Rohtak presently posted as Deputy Commissioner, Rohtak do hereby appoint the Additional Deputy Commissioner, Rohtak as Returning Officer and SDO (Civil) ,Rohtak as Assistant Returning Officer(HQ) for conducting the Election of all the 105 Collegiums as per the schedule mentioned above.

The draft voter list collegiums - wise and election schedule is hereby published today i.e. 25.01.2016 (Monday) and a copy of the same has been uploaded on the website of Jat Education Society (Regd.), Rohtak i.e. jesrohtak.org. A brief of this order is being published in two National Newspapers for wide publicity.
